PRE-QUALIFICATION OF SOLAR BASED FIRMS

Agency for Barani Areas Development (ABAD), Planning & Development Board, Government of the Punjab, has launched a project titled "**WATER RESOURCE DEVELOPMENT IN EXPANDED AREAS OF ABAD**" in the three district of Punjab Barani Tract i.e. D.G Khan, Rajanpur & Mianwali where Solar Water Pumping System is a component for efficient utilization of Renewable Energy Sources in Punjab. ABAD intends to shortlist the firms capable of supplying and installing the Solar Powered Water Pumping System. Companies/ Firms, having the experience of supplying/installing of Solar Systems preferably in proposed districts and fulfill the following eligibility criteria are requested to apply for pre-qualification:

Eligibility Criteria:

1. Company profile, contact address and relevant details.
2. Details of solar systems projects completed alongwith contractual amounts, dates of commencements & completion alongwith agency name containing a list of solar pumping system installed during last five years.
3. List of current client in Government / Public/ private sector alongwith contact, personal Name, Address, Telephone number and anticipated date of completion of projects.
4. List of key personnel alongwith their CVs.
5. Audited accounts for the last five years & bank statement of last five years.
6. Detail of machinery and equipment etc.
7. Details of technical staff & details of specialty in the field of solar systems.
8. The firms must have relevant experience for installation of solar water pumping system and test bed facility in premises of firms/certification of quality standard of items, registered with PEC in C3 or above category and also registered with SECP.
9. Incomplete proposal shall be rejected.
10. Pre-qualification and selection of interested company/ firm will be carried out in accordance with PPRA rules 2014 with amendments.
11. Affidavit that the company/firm have not been blacklisted by any Government/Semi Government / Autonomous Body or private company.
12. The companies/Firms must be registered with sale Tax and Income Tax Department (copy of valid NTN certificate and sale tax certificate must be provided and must be at active tax payer list).
13. ABAD reserves the right to accept/ reject all the offers without assigning any reason.

The application alongwith all the requisite documents as mentioned above must be submitted in the office of Director General, Agency for Barani Areas Development (ABAD), Planning & Development Board, Government of the Punjab, Murree Road, Rawalpindi before **12th February 2021 at 02:00 P.M.** The proposals will be opened on the same day at 02:30 P.M. in the presence of technical committee/staff of ABAD.
