VISION AND GOALS:

Environment Protection Department aims to promote sustainable development in the province through integration of environmental considerations in pursuit of economic growth. Consequent to the devolution of the subjects of Environment and Ecology through 18th Constitutional Amendment, the environmental affairs of the province are regulated by Punjab Environmental Protection Act (amended 2012) and Rules made there under. Environment Protection Department is responsible for administration of the laws and rules in order to provide for the protection, conservation, rehabilitation and improvement of the environment, for the sake of prevention and control of pollution.

IMPORTANCE OF ENVIRONMENT PROTECTION FOR ECONOMIC GROWTH:

Environmental protection and conservation aims to reduce the adverse impact on environment with the increase in industrialization and economic growth. There is a direct link of pollution on air, water and land, which in turn seriously affect the economic growth. Therefore it is imperative to reduce the impact of pollutants on environmental resources for existence of life and sustainable development. Punjab Government's commitment towards environment protection envisions a clean, protected and safe environment for public that ensures environmental sustainability for future generations. The compliance of regulatory regime for environmental protection is vital for protection of environment and sustainable development.

- Capacity Building of EPA Punjab for Enforcement of Environmental Standards in Punjab including Combined Effluent Treatment Plants (CETPs) and Industrial Estates (IEs) under J&C Program
- ➤ Capacity building of field offices of EPA Punjab for enhanced environmental quality monitoring systems for Punjab's air, surface and ground water resources.
- Restructuring and capacity building of Environment Protection Department (EPD) to effectively enforce the regulatory framework and environment protection.

- 3. Capacity building of field office of Environmental Protection Agency to effectively monitor the Air & Water
- 4. Commencement of activities under ADB Technical Assistance for Revitalization of ecosystem of River Ravi.
