In this context, Web Based Prequalification System (WBPS) has been developed and introduced on the website of Directorate General Monitoring and Evaluation (DG M&E). Interested Individual consultants and firms/companies including joint ventures meeting the below mentioned criteria as a prerequisite may download the pre-qualification document (POD) from the website (www.dgmpunjab.gov.pk) of DG M&E and submit their response on the WBPS. The Individual consultants, firms / companies are advised to submit their responses on the online WBPS and hard copies of the same duly generated from the WBPS. **Last date for submission of EOIs, through WBPS, is April 30, 2021 till 4:00 pm and the hard copies duly generated from WBPS must be submitted by May 05, 2021 till 4:00 pm.**

Note:

- Each page of hard copy generated from WBPS must be signed and stamped by firm/company.
- Each page of hard copy generated from WBPS must be signed by Individual Consultant.
- Hard copies of only those Individual consultants and firms/companies will be accepted who have submitted their EOIs electronically through WBPS within the above mentioned time frame.

PREREQUISITE FOR PRE-QUALIFICATION/SHORTLISTING

Individual Consultants:

- Minimum professional qualification must have registration with the HEC / ICAP / PMDC / PEC / PCATP etc.
- National Tax Registration Number with active taxpayer status.
- Undertaking by the Individual Consultant on a simple paper duly signed that he/she has not currently blacklisted by any Federal, Provincial / State or Local Government Department and / or by any Government owned company / foundation / Agency / Authority.
- Minimum 07 years of relevant experience.

Firms / Companies:

- Valid registration with the relevant professional body (e.g. PEC, PCATP, ICAP, PMDC, ICMAP or relevant bar councils).
- Registration with SECP, Registrar of Firms, Chamber of Commerce, or any other body depicting legal status of Firm, Company or Organization.
- Registered with Federal/Provincial Tax/Revenue Authorities with Active Tax Payers' status.
- Undertaking by the firm/company on a legal paper/stamp paper/Letter Head that it is not blacklisted by any Federal, Provincial, State or Local Government department and/or by any Government owned Company/ Foundation / Authority / Autonomous Body / Attached Department.

Pre-qualification/shortlisting of Individual consultants and firms/ companies will be done in accordance with the criteria defined in POD. List of Pre-qualified Individual consultants and firms / companies will be valid for FY 2021- 2022. The scope of work is tentative for prequalification only. The actual scope of work will be provided by the line department(s) at the time of issuing RFP as per actual scope of work. However, pre-qualification / shortlisting of any Individual consultant and firm / company does not guarantee award of work and it depends on availability of assignment with the line departments, technical and financial evaluation of proposal submitted by consultants for a specific work at a later stage in accordance with amended Rule 16 of PPRA Rules, 2014.
