All Bids must be accompanied by a Bid Security of 2 % of the estimated price in the form of CDR/Demand Draft Pay Order. Bids received after the specified date and time shall be rejected. The Bids will be opened on the same day at <u>04:00 PM</u> Hours in the presence of the Bidders' representatives who may choose to be present at the address below.
- 4. Bids which are incomplete, not sealed, not signed and stamped or not in accordance with the specified mode, will not be considered.
- 5. Income / sales tax registration certificate and other documents as mentioned in Tender Document must accompany the bids. Taxes will be deducted as per law.
- 6. All quoted prices should be excluding of GST.
