## **TERMS & CONDITIONS:**

- 1. The interested bidders will be liable to submit their bids keeping in view their speciality/area of work
- 2. As per Punjab Procurement Rules, 2014 "Single Stage, Two Envelops" procedure will be followed. Single package shall contain two separate envelopes. Each envelope shall be clearly marked as "Technical Proposal" and "Financial Proposal".
- 3. The bid validity period shall be for the whole financial year 2021-22
- 4. The procuring agency shall disqualify a bidding firms if it finds, at any time, that the information submitted by firm regarding its qualification as bidding firms was false and material/inaccurate or incomplete
- 5. Bid security / earnest money of successful bidder(s) will be retained as Security deposit (till completion of assignment) and that of the rest bid security/earnest money of unsuccessful bidder will be released upon their request
- 6. Evaluation Committee will carry out the evaluation in two stages by awarding opportunity of open competitive bidding-Rule-23 PPRA, 2014. At first stage the technical evaluation (relevancy to the assignment, capacity to perform duty, financial soundness etc.) will be carried out and in second stage financial evaluation of the technically successful bidders will be carried out.
- 7. The amount of Bid shall be in Pak rupees.
- 8. Bank Guaranty in favour of Agency for Barani Areas Development on account of Earnest Money @ 2% of the estimated cost i.e. 0.3 million must be attached with the Financial Bid.
- 9. Detailed Tender documents under section 25 of PPRA Rules 2014 can be collected from the office of Director General, ABAD, Rawalpindi during office timings on payment of cash of Rs.1,000/- (non-refundable).

- 10. Bids offered by blacklisted firms shall not be considered and all bidders shall give in writing undertaking that they are not blacklisted by any department/government. If at any stage, it is found that the bidder is already or has become blacklisted, his bid shall be rejected forthwith, and further action will be taken as per PPRA Rules, 2014.
- 11. The bidders can submit their sealed tenders on 5<sup>th</sup> January, 2022 till 02:00 P.M. in the office of the Director General, ABAD, Murree Road, Rawalpindi and Technical bids will be opened on the same date at 04:00 P.M. by the procurement committee in the presence of bidders or their authorized representatives who may wish to attend.
