In this context, Web Based Prequalification System (WBPS) has been developed and introduced on the website of Directorate General Monitoring and Evaluation. Interested Individuals meeting the below mentioned criteria as a prerequisite may download the pre-qualification document (PQD) from the website ([www.dgmpunjab.gov.pk](http://www.dgmpunjab.gov.pk)) of Directorate General (Monitoring & Evaluation) and submit their response on the WBPS. The Individuals are advised to submit their responses on the online WBPS and hard copies of the same duly generated from the WBPS and each page signed by the same Individual, must be submitted to the office of DGM&E for further evaluation. **Last date for submission of EOIs, through WBPS, is October 15, 2020 till 4:00 pm and the hard copies duly generated from WBPS and each page signed by the Individual, must be submitted by October 20, 2020 till 4:00 pm.**

Note: Hard copies of only those Individuals will be accepted who have submitted their EOIs electronically through WBPS within the above-mentioned timeframe.

### PREREQUISITE FOR PRE-QUALIFICATION/SHORTLISTING

- Valid Registration with the relevant professional body (e.g. PEC, PCATP, PMDC, ICAP etc.)
- National Tax Registration Number with active taxpayer status.

Pre-qualification/shortlisting of Individual Consultants will be done in accordance with the criteria defined in PQD. List of Pre-qualified Individual Consultants will be valid till June 2021. The scope of work is tentative for prequalification only. The actual scope of work will be provided by the line department(s) at the time of issuing of invitation for submission of proposal as per actual scope of work. However, pre-qualification / shortlisting of any Individual Consultant does not guarantee award of work and it depends on availability of assignment with line departments and evaluation of proposal submitted by consultants for a specific work in accordance with amended Rule 16 of PPRA Rules, 2014.
