**SUBJECT: MULTILATERAL TRAINING PROGRAMS IN AGRICULTURE AREA UNDER CHINA AID IN AUGUST, 2025**

The undersigned is directed to refer to this Ministry's letter of even no. dated June 17, 2025 and subsequent reminder dated July 2, 2025 on the subject noted above (Copy enclosed).

2. It is stated that as per the desire of the Prime Minister of the Islamic Republic of Pakistan, the Government of the People's Republic of China is offering training programs in the Agriculture sector, which are continuously being circulated to the relevant Ministries and Provincial Governments. ## OFFICE MEMORANDUM

**SUBJECT: MULTILATERAL TRAINING PROGRAMS IN AGRICULTURE AREA UNDER CHINA AID IN AUGUST, 2025**

The undersigned is directed to state that the Government of the People's Republic of China has offered Multilateral Seminars, in agriculture area for the month of August, 2025 for officers of the Government of Pakistan (**List and program details are attached**). The Chinese side has further informed that the candidates **cannot be withdrawn once nominated** and the final application result will be subject to the MOFCOM. The Government of Pakistan will not be liable to bear any cost. The requisite general requirements are as under:

### Eligibility Criteria

- Officers (**BS-17 & above**) of Ministries / Divisions and Provincial Governments most relevant to the training programmes.
- Proficiency in English.
- **Maximum age limit is 50 years for BS 20 & above, and 45 years for BS 17-19.**
- **Contract Employees are not eligible**

### Documents Required

The following documents are required to be sent along with the nomination:

- Application Form (**02 sets**)
- Information Form duly filled in by the nominee (**02 sets**)
- Copy of Passport at least six months of remaining validity and blank visa pages (**02 sets**)
- Medical Certificate (Foreigner Physical Examination Form) (**02 sets**)
- No criminal record certificate or Police Clearance Certificate attested by Ministry of Foreign Affairs of Pakistan, if not visited China within 5 years (**02 sets**)
- FTC Proforma
- Copy of CNIC
- Surety Bond on stamp paper
- Undertaking on stamp paper

**3.** The relevant Ministries / Divisions and Provincial P & D Departments must note the following points while nominating the candidates:

1. Most relevant candidates should be nominated for the Seminars.
2. Nomination of the candidates should reach MoEA before the deadline. Late the arrival of nomination, after the MoEAs' deadline, will not be entertained.
3. Nomination papers, complete in all respect, may be forwarded to EAD through proper channel i.e. through their respective Administrative Ministry / Division/ P&D Department.
4. All candidates must follow code of conduct ([Annex-I](#))

8. You are not allowed to work, because you receive living allowance from China and the purpose of your stay in China is to engage in study / research.
9. Universally courtesy and politeness costs nothing and only earn friends. It is always beneficial to be courteous and polite. Politeness is not a sign of weakness. It shows good breeding, education and upbringing.
10. Female colleagues must be respected. They are fellow officers. Some very basic things shall be considered while interacting with the female colleagues:
  - Generally, as a mark of respect, one should stand when a female enters a room.
  - Personal space should be respected during conversation and a comfortable distance should be maintained.
  - Personal remarks on their dress and appearance should be avoided.
  - Loose language or inappropriate terms should not be used.
  - Inappropriate jokes should not be cracked.

- Hand gestures universally deemed obscene should not be made.
- Staring should be strictly avoided.
- Situations that make female colleagues uncomfortable should be avoided.
- While talking to a female, hands should never be placed in trousers pockets.
- Personal questions should never be asked (age, height, weight, marital status etc).
- Ordinarily, men should open the door for women.
- Females should always precede a male while entering a room.
- Door of a car should be opened for a female colleague.

11. Psychological harassment is against Chinese norms, that shall strictly be avoided:

- a. Persistent, unjustified and unnecessary negative attacks on personal or professional performance;
- b. Manipulation of an employee's personal or professional reputation by rumor, gossip or ridicule;
- c. Offensive comments or behavior relating to the ethnic origin, physical characteristics or religion of an individual;
- d. Exclusion or continued isolation from professional activities;

That means (1) Systematic policy support: Build a responsibility system of "five-level secretaries focusing on rural revitalization", introduce top-level designs such as the "Comprehensive Rural Revitalization Plan (2024-2027)", and coordinate policy resources such as finance, land, and banking to favor rural areas. (2) Integrated development of the three industries: through the "Internet + agriculture" and "garden complex" and other models to promote the deep integration of agriculture with tourism, e-commerce and culture. (3) Ecological protection and green transformation: promote ecological compensation mechanism, implement projects such as returning farmland to forest and toilet revolution. (4) Digital technology empowerment: Build a pilot digital village, use big data and blockchain technology to optimize the supply chain of agricultural products, and broaden sales channels with the help of live e-commerce. (5) Talent and organization revitalization: the implementation of the "college student village officials" and "villager return" plan,</p>	

strengthening the leading role of grass-roots party organizations, establishing autonomous mechanisms such as "villagers' councils", and improving the effectiveness of rural governance. Through systematic training, this seminar enables participants to fully grasp the core theories, policy tools and practical paths of coordinated urban-rural development and rural revitalization, and improve their ability to develop strategic plans, promote industrial upgrading and optimize rural governance. The activities of the seminar are divided into three parts: thematic lectures, discussion and exchange and field visit.

I. Thematic Lectures. It includes 2 public courses and 8 professional courses.

(I) Public Courses

1. Introduction to China's National conditions. This lecture mainly introduces the basic national conditions of China and the main results, strategic measures, model mechanisms and experience enlightenment of China's economic and social development.

2. Promote the building of a community with a shared future for mankind. This lecture mainly introduces China's strategic conception, promotion model, policy measures and effectiveness inspiration in promoting the building of a community with a shared future for mankind.

(II) Professional Courses

3. Strategy and practice of urban-rural integration in China. This lecture mainly introduces the strategic measures, policy design, model mechanism and experience enlightenment of China's urban-rural integration development.

4. China's rural revitalization strategy and policy. This lecture mainly introduces the strategic measures, policy design, model mechanism and experience enlightenment of China's rural development and rural revitalization.

5. China's rural industrial development policy and practice. This lecture mainly introduces the strategic framework, policy measures, main effects and experience enlightenment of China's rural industry revitalization.

6. China's rural education development policy and practice. This lecture mainly introduces the strategic framework, policy practice, main effect and experience enlightenment of rural education development in China.

7. China's rural health development policy and practice. This lecture mainly introduces the strategic framework, policy practice, main effect and experience enlightenment of China's rural health development.

8. China's rural science and technology development policy and practice. This lecture mainly introduces the strategic framework, policy measures, main effects and experience enlightenment of China's rural science and technology development.

9. China's rural ecological environment policy and practice. This lecture mainly introduces the strategic framework, policy practice, main results and experience enlightenment of promoting rural ecological construction and strengthening green development in China.

10. Effectiveness in formulating and implementing local and provincial rural revitalization policies. This lecture mainly introduces the formulation, policy measures, implementation model and experience inspiration of local provincial rural revitalization planning.

The itinerary for field visit and the courses arrangement may be adjusted according to the actual situation.

3. In case of an emergency, please promptly inform the staff for immediate assistance.
4. Please ensure the safety of your personal belongings and consider storing them in the hotel if needed.
5. If you have any specific dietary requirements, kindly inform the staff as soon as possible.
6. When visiting scenic spots and historical sites, please be attentive to signs indicating that photography is not allowed.
7. Please observe Chinese laws and Regulations during your stay. Especially the norms of “sexual harassment” can be different from your country’s. Please avoid inappropriate and undesirable situations, which can lead to the termination of your program and draw legal consequences. 8. You are not allowed to work, because you receive living allowance from China and the purpose of your stay in China is to engage in study / research.
9. Universally courtesy and politeness costs nothing and only earn friends. It is always beneficial to be courteous and polite. Politeness is not a sign of weakness. It shows good breeding, education and upbringing.
10. Female colleagues must be respected. They are fellow officers. Some very basic things shall be considered while interacting with the female colleagues:
  - Generally, as a mark of respect, one should stand when a female enters a room.
  - Personal space should be respected during conversation and a comfortable distance should be maintained.
  - Personal remarks on their dress and appearance should be avoided.
  - Loose language or inappropriate terms should not be used.
  - Inappropriate jokes should not be cracked.

- Hand gestures universally deemed obscene should not be made.
- Staring should be strictly avoided.
- Situations that make female colleagues uncomfortable should be avoided.
- While talking to a female, hands should never be placed in trousers pockets.
- Personal questions should never be asked (age, height, weight, marital status etc).
- Ordinarily, men should open the door for women.
- Females should always precede a male while entering a room.
- Door of a car should be opened for a female colleague.

11. Psychological harassment is against Chinese norms, that shall strictly be avoided:

- a. Persistent, unjustified and unnecessary negative attacks on personal or professional performance;
- b. Manipulation of an employee's personal or professional reputation by rumor, gossip or ridicule;
- c. Offensive comments or behavior relating to the ethnic origin, physical characteristics or religion of an individual;
- d. Exclusion or continued isolation from professional activities;
